AMONG OTHER CHANGES, THE MANAGEMENT SERVICES AGREEMENT BETWEEN PCAP AND TCF WAS TERMINATED; PCAP HIRED AS ITS OWN OFFICERS AND EMPLOYEES OF THE TCF PERSONNEL WHO PREVIOUSLY PROVIDED SERVICES FULL-TIME TO PCAP, PROCURED ITS OWN PAYROLL AND INFORMATION TECHNOLOGY SERVICES, ESTABLISHED STANDALONE BENEFITS PLAN DOCUMENTS; TCF ASSIGNED TO PCAP CERTAIN INTELLECTUAL PROPERTY RIGHTS (INCLUDING THE USE OF THE NAMES "PCAP," "PARTNER COMMUNITY CAPITAL, AND OUR FORMER NAMES, "NATURAL CAPITAL INVESTMENT FUND" AND "NCIFUND"); AND PCAP OBTAINED ITS OWN DETERMINATION FROM THE INTERNAL REVENUE SERVICE ("IRS") THAT PCAP WOULD CONTINUE TO BE EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE CODE AFTER SEPARATION.

THE SEPARATION OF PCAP AND TCF OPERATIONS WAS COMPLETED EFFECTIVE MARCH 31, 2022. ALL TCF OFFICERS WHO SERVED ON PCAP'S BOARD OF DIRECTORS HAD STEPPED DOWN AS OF JUNE 30, 2022. THE IRS FORMALLY ACCEPTED PCAP'S NAME CHANGE IN MARCH 2023.
